Ministerial Musings

Each June, we celebrate Pride Month here at FPUU—a time to uplift and honor the lives, identities, and contributions of our LGBTQIA+ siblings. As Unitarian Universalists, this is more than a celebration. It is a sacred commitment rooted in our deepest values: the inherent dignity of every person, justice, equity, and the goal of world community with peace, liberty, and justice for all.

Pride Month began as a commemoration of the Stonewall Inn uprising in June 1969. In response to a police raid on a gay bar in New York City, LGBTQIA+ people—led by trans women of color like Marsha P. Johnson and Sylvia Rivera—rose up against decades of

harassment, discrimination, and violence. This act of resistance ignited a movement for LGBTQIA+ rights

that continues to this day. Pride is not just a time to happily wave rainbow flags, but is rooted in protest, resilience, and the demand for liberation.

It is vital to remember this history—not only to honor those who fought, but to recognize that the struggle for justice is far from over. Today, anti-LGBTQIA+ legislation, particularly targeting trans and nonbinary people, is on the rise. Pride is not just a celebration; it is a call to action.

Unitarian Universalism has long stood with the LGBTQIA+ community. In 1970, our faith began ordaining openly gay clergy. In 1984, we became the first religion to approve religious same-sex unions. We affirmed transgender inclusion in 2007 and continue to advocate for full legal and social equality. Our congregations, including this one, are called to be places of radical welcome and spiritual refuge for people of all sexualities and gender identities.

But affirmation is not enough. Pride Month invites us to deepen our solidarity. That means amplifying LGBTQIA+ voices, challenging injustice, educating ourselves and others, and creating communities where everyone can live freely and authentically. It means showing up—not only in parades and celebrations—but in the voting booth, in the streets, and in our everyday lives.

To celebrate Pride is to affirm life. To live our faith during Pride is to declare, again and again, that love is love, that trans rights are human rights, and that every person is a beloved part of the interdependent web of existence.

Let us move through this month with joy and reverence, with courage and compassion, honoring all who came before and committing ourselves to a future where everyone can thrive.

The Executive Board hereby notifies all voting members of First Parish Unitarian Universalist Medfield of the Annual Parish Meeting, to be held **in person in the sanctuary and on the Zoom conference platform** beginning at 11:30 am on Sunday, June 8, 2025. A quorum of 25 percent of Full Members eligible to vote at the time of posting of this notice must be present to conduct the business of the Congregation. This translates to 18 members.

In accordance with the Church Bylaws of First Parish Medfield (approved on June 3, 2012) in Article 4.1, the Annual Meeting is described as follows:

Article 4.1.1 Time and Place: The Annual Meeting of the Parish shall be held at some date between the first of May and the last day of June in the Church or other such place, as determined by the Executive Board.

Article 4.1.2 Purpose: The annual Parish meeting shall be held for the following purposes:

Article 4.1.2.1 Accepting reports from the Minister, all officers, standing committee chairs, and representatives of various Church organizations.

Article 4.1.2.2 Electing officers to the Executive Board to fill vacancies resulting from expired terms or from resignations.

Article 4.1.2.3 Verifying acceptance of Parish organizations.

Article 4.1.2.4 Electing a Nominating Committee for the forthcoming year.

Article 4.1.2.5 Approving the Operating and Capital Budgets for the forthcoming fiscal year.

The meeting should last about one and a half hours. Thank you on behalf of the Executive Board.

A Motion to amend the Bylaws to modify the number of officers required for the Executive Board (with necessary adjustments to other articles)

Rationale. The current Article 5.2 of the Bylaws requires a board of seven members. This has proven to be a difficult number to achieve. Those who have served on the Nominations Committee regularly report difficulties in filling all seven positions. Depending on the overall membership of the Society, there may not be a sufficient number of qualified or willing congregation members to fill all positions. In years where special committees are formed (e.g., a ministerial search committee, a capital campaign committee), the challenge to fill seven board positions is exacerbated. Current board members with experience of boards in business and non-profits report that a flexible board size is common. With that in mind, the Executive Board asks for a positive vote on this motion, which would change the required board size from seven (7) to five to seven (5-7).

Proposed language to amend Articles 5.2, 5.4, 6.1.4, and 6.1.5 of the Bylaws, which pertain to the size of the Executive Board, its officers, a quorum, and a voting majority.

CURRENT LANGUAGE:

Article 5.2. Size

The Executive Board has seven (7) members.

PROPOSED LANGUAGE:

The Executive Board will be made up of five (5) to seven (7) members.

The Nominating Committee will strive to maintain 3 At-Large Members on the Executive Board.

CURRENT LANGUAGE:

Article 6.1.4. Quorum. At any meeting of the Executive Board, five (5) members shall constitute a quorum. When fewer members are available, those present may reschedule the meeting. No binding vote may occur without a quorum.

PROPOSED LANGUAGE:

Article 6.1.4. Quorum. At any meeting of the Executive Board, the quorum for a five-member or six-member board will be four (4) members. The quorum for a seven-member board will be five (5) members. When fewer members are available, those present may reschedule the meeting. No binding vote may occur without a quorum.

CURRENT LANGUAGE:

Article 6.1.5. Executive Board Voting Majority. All votes of the Executive Board require a voting majority of four (4) members present and voting.

PROPOSED LANGUAGE:

Article 6.1.5. Executive Board Voting Majority. All votes of the Executive Board require a voting majority of four (4) members present and voting. In cases of a tie vote, the motion will not pass.

Monthly Mediation & Reflection

Seeds carry within them the power to shape the gardens of our inner and outer lives.

First, I invite you to close your eyes for a moment and receive each of the following sentences. Feel what arises within you—not just mentally, but emotionally and even physically.

1. "You are not good enough. You always fail."

Just notice what stirred. Perhaps a tightening in your chest, a sinking in your stomach, or a cascade of self-critical thoughts.

2. "You are deeply loved. There is great strength within you."

Again, notice. Is there a softening? A feeling of warmth? Perhaps a spark of hope?

This is the power of words.

The Power of Words Described

Words are **living vibrations**. They don't simply pass through the air—they enter us, imprint upon our consciousness, and ripple through our being.

- Negative words are like dark clouds that gather in the psyche. Repeated often enough, they harden
 into beliefs: "I'm unworthy," "I can't," "The world is dangerous." These beliefs mold your perception,
 and perception becomes your reality.
- **Positive words**, spoken with truth and care, are like light. They clear the fog of self-doubt. They remind the soul of its original brilliance. Over time, they rebuild identity and purpose.

In spiritual traditions, this is why mantras, prayers, affirmations, and sacred texts are recited aloud—not just read. The voice carries energy. **The tongue creates worlds**.

Impact on One's Way of Being

Your inner dialogue becomes your outer behavior.

- A child told "you are stupid" may become a withdrawn adult, afraid to speak.
- A soul reminded, "you have wisdom," may rise to lead with compassion and courage.

Consider: The world you see is filtered through the language you use. If you constantly say, "Life is hard," your body will brace for struggle. If you learn to say, "Life is a teacher," you meet each trial with curiosity instead of fear.

Words shape your **relationship to self**, to **others**, and to the **divine**.

An Invitation

Speak today as if every word plants a seed.

- To yourself: "I forgive you. I believe in you."
- To another: "You matter. I see your light."
- To life: "I trust the unfolding."

In this way, your way of being becomes a healing presence, not just for you—but for all who hear you speak.
